Motion carried 2-0. Vice Chairman said that the Board discussed personnel and litigation matters in executive session and she asked if there were any motions to come before. Mr. Cramer made a motion to **authorize an increase in hourly rate of pay for Kevin Hill as a Seasonal Snow Plow Driver from \$20/hour to \$30/hour retro-active to January 14, 2019 due to the fact he has a Class B CDL License.** Mrs. Wilkins seconded. Mr. Cramer and Mrs. Wilkins voted aye, motion carried 2-0. Mr. Cramer moved to **approve the hiring of Craig Coslar as a full time Heavy Equipment Operator/Laborer with a Class B CDL at a starting rate of \$18/hour with full benefits starting after the 30 day probation period and a start date on or around February 19, 2019.** Mrs. Wilkins seconded.
