### NOTICE TO BIDDERS

Sealed bids will be publicly opened and read by the Stroud Township Board of Supervisors on Tuesday, November 16, 2021, at 7:00 PM, prevailing time, at the Stroud Township Municipal Center, 1211 North Fifth Street, Stroudsburg, PA 18360 for the lease of the following, to wit:

Sixty-five (65) 2022 model year Yamaha Quietech EF1, or equal, two-person gasoline golf carts and four (4) 2022 model year Yamaha gasoline utility vehicles, or equal. Bids shall include payment in full for the balance of existing leased sixty-five (65) Yamaha DR2A golf carts and four (4) Yamaha YT2A utility vehicles upon delivery of new golf carts, such delivery occurring no later than March 1, 2022. Bids shall provide for a lease term up to eighty-four (84) months, with equal monthly payments for eight (8) months, or less, of each year for the duration of lease term. Bidders shall also include an option to "roll" into a new lease. The roll option may be exercised in the Township's sole discretion any time after the 60th month of the lease, at no additional cost or penalty.

Said equipment shall meet or exceed the minimum requirements of detailed specifications established by the Township and shall be provided with a minimum four (4) year warranty. Complete specifications are available at the Township Municipal Center during normal office hours. Copies of the specifications are available upon request.

All bids shall be received by the Township Manager by 2:00 PM prevailing time, Tuesday, November 16, 2021. All bids shall be submitted on forms provided by the Township. All bids shall be submitted in a sealed envelope and plainly marked "GOLF CART BID". Each bid must be accompanied by proposal security in the amount of ten (10%) percent of the total bid. Security shall be in the form of a certified check, bank cashier's check, or satisfactory bid bond naming as payee the Township of Stroud. No bids or proposals may be withdrawn for a period of sixty (60) days after the date above specified for receiving, opening, and reading of bids, or contrary to Act 4 of 1974 regarding the withdrawal of bids.

The successful bidder shall be a dealer or distributor of the equipment being leased and shall have service technicians and parts available no less than bi-weekly for normal maintenance at designated Stroud Township location.

The Stroud Township Board of Supervisors reserves the right to reject any and/or all bids, or parts thereof, and to waive any defects, irregularities or portions thereof, as deemed to be in the best interest of the Township.
