All voted aye, motion carried 3-0. Mr. Cramer made a motion to **return to regular session 8:04 P.M.** Mrs. Wilkins seconded the motion. All voted aye, motion carried 3-0. Mrs. Wilkins said that the Board discussed personnel and litigation matters in executive session and she asked if there were any motions to come before. Mr. Cramer made a motion to **offer employment to a candidate that was recommended by the Public Works Superintendent at the rate of \$18/hour and after completion of CDL Alcohol and Drug testing.** Ms. Shukaitis seconded the motion. All voted aye, motion carried 3-0. Ms. Shukaitis made a motion **to renew the Employment Agreement of Daryl A. Eppley, dated 2/28/2019, commencing 1-5-2020 and terminating 1-3-2022, on the same terms and conditions as approved by Stroud Township Resolution No. 2019-36 pursuant to Stroud Township Ordinance No. 2-2019 and the Second Class Township Code, Act of 11-9-1995 (P.L. 350, No. 60, 53 P.S. 66301). Salary shall be set for the two year period as set forth in Section 3., Compensation, (a)(ii) of the Employment Agreement, at \$103,250.00 for the period of 1/7/2020 through 1/4/2021, and \$107,250.00 for the period of 1/5/2021 and 1/3/2022.** Mr. Cramer seconded the motion. All voted aye, motion carried 3-0.

There being no further business, Mr. Cramer **made a motion to adjourn the meeting at 8:07 P.M.** Ms. Shukaitis seconded the motion. All voted voted aye, motion carried 3-0.
