### **MEETING MINUTES**

## REGULAR MEETING, December 15, 2020, 7:00 P.M.

The Regular Meeting of the Stroud Township Board of Supervisors was called to order by Chairwoman & Secretary, Christine A. Wilkins at 7:00 P.M. and was conducted remotely by internet utilizing Zoom.us. Also attending were Vice Chairwoman & Ass't Secretary, Jennifer Shukaitis; Supervisor/Ass't Treasurer Edward C. Cramer; Township Manager, Daryl A. Eppley; Township Solicitor, Todd Weitzmann; and Recording Secretary, Janice Willey. Mrs. Wilkins began the meeting with the Pledge of Allegiance. (On December 14, public notice was posted on Township website and Facebook page inviting remote public participation by email, phone and/or Zoom.us.)

Public Comments: (Non-Agenda Items) There were no Public Comments.

**Treasurer's Report: Month of November.** Mr. Eppley read the report aloud. Ms. Shukaitis moved to accept **Treasurer's Report: Month of November.** Mr. Cramer seconded. All voted aye, motion carried 3-0

**Manager's Report:** Mr. Eppley reported there is still no update on disaster aid from PEMA on Tropical Storm Isaiah from August 4<sup>th</sup>. Tomorrow there is an update call with PennDOT regarding the Mervine Bridge Replacement Project. We received the DEP 902 Grant of \$350,000 to replace the leaf vacuums and recycling equipment at Gaunt Road. We placed our first salt order today for the 2020-2021 season and gift baskets have been delivered to Township volunteers.

**Public Works Dept. Report:** Mr. Eppley read Douglas Walker's report, it said the Road Crew has been working on the following: the 2020 Leaf pick-up has been completed; the crew took down the old garage/barn on the ham house property; they hauled 4 loads of cardboard out of that property to the Waste Authority in Blakeslee; he had the crew prepare the equipment and trucks for the winter season; the sledding hill is ready to go; next week he will have them focus on completing the installation of the skating rink, weather permitting; and as always they are working hard on the "Request for Action" forms as they come in.

**Police Report:** Officer Raymond reported there were not any robberies or assaults in Stroud Township for the month of November, but unfortunately there was one burglary. Accidents are about even from last year this time and expect that to go up with the winter season upon us. He asked if there were any questions for him regarding the report. There were none.

**Solicitor's Report**: Mr. Weitzmann said he distributed a draft ordinance for C-4 zoning earlier today. He's looking for some input from the board on that and the rest of his report would be for Executive Session.

**Engineer's Report:** Mr. Eppley read Mrs. Alker's report. She is working with property owners on stormwater maintenance issues. She is working with PennDOT regarding a potential partnership on

sediment reduction. Mrs. Alker is putting together a PowerPoint presentation for a staff workshop. There was a meeting with Reilly Associates on getting estimates for the Brushy Mountain Road and Rt. 447 Drainage issues to be submitted for grant funding and continuing to work on ongoing SALDO Projects.

**Fire Department Report:** Mr. Swope reported the department received notification papers stating the Stroud Mall filed bankruptcy and expressed his concern considering this is a big part of the department's income. They have hired a lawyer to represent them regarding this issue. He mentioned the fundraising mailer went out and they are hopeful for a good return, but understands these times are hard for everyone. There was also a discussion on applying for grants and the proper way to do so. Mrs. Wilkins thanked Mr. Swope for his report and mentioned it is nice having representation from the department at the meetings.
