Treasurer, Edward Cramer; Supervisor/Ass't. Secretary, Susan Lyons; Township Manager, Daryl A. Eppley; Township Engineer, Chris McDermott, P.E., of Reilly Associates; Township Solicitor, Todd Weitzmann; and Recording Secretary, Janice Willey. Ms. Shukaitis began the meeting with the pledge of allegiance.

<u>Public Comments:</u> (Non-Agenda Items) George and Mary Palencar and Dale and Darlene Crouse attended the meeting to speak to the Board about a neighbor burning at 3167 Shafer Schoolhouse Road. Mr. Eppley gave them an update on the issue. There was also a discussion about PennDOT's I80 Project and Shafers schoolhouse Rd.
