Manager's Report: Mr. Eppley reported RKR Hess has prepared the bid documents for the Mervine Road Bridge project and close to getting the Blue Ridge Cable utility relocation from PennDOT for approval to proceed. Monroe County Planning Commission has the traffic count in progress for the speed hump analysis on Power House Lane. The Hazard Mitigation plan is ongoing. Fuel and Paving bids have been advertised for a 6/1 let date. We are waiting on the last of the invoices for a final count for Spring Clean-up. Mr. Eppley will schedule a meeting with Mrs. Alker and Reilly Associates to finalize the project package for Route 447 and Brushy Mountain Road Intersection and drainage improvements estimated at \$1,650,000.00 for grant submittal to Senator Scavello's office. Police negotiations are in progress and waiting to hear back within the next week on the latest proposal. He attended PSAT's webinar on the American Rescue Plan and circulated information for the Board's review. The cleanup has begun at Penn Hills and the first dumpster load was filled and hauled away. The fence gates have been chained and locked and warning signs have been ordered. A demolition permit has been obtained for the first structure and we will have to get individual permits for each structure as they are taken down. The grant agreement with DEP for Section 902 Municipal Recycling for \$350,000 is in progress for electronic signature.

<u>Public Works Dept. Report</u>: Mr. Eppley read Douglas Walker's report. It stated the Road Crew's main focus this month has been 2021 Spring Clean-Up. This year we saw more cars than in the past. The Miller Street tree is down. We are very busy at Gaunt Road. The garbage around the road and fencing at Penn Hills has been cleaned up. And as always they are working hard on the "Request for Action" forms as they come in.

<u>Police Report</u>: Officer Raymond had technical difficulty while trying to join the meeting. No one had any questions for Officer Raymond.

Solicitor's Report: Nothing to report.

Engineer's Report: Mr. Eppley summarized Mrs. Alker's report, she has been working on the Zoning Ordinance Amendments and should be ready to move forward with them shortly. Regarding Stream Bank Stabilization, she

provided some projects PennDOT might be interested in. It looks like we are close to wrapping up the NPDES permit project with St. Luke's. And she is continuing her ongoing SALDO projects.
