Before going into Executive Session, Ms. Shukaitis said she had invited Christopher Martin to join our meeting. He was the only registrant attending tonight's meeting, he was representing the Stroud Township Volunteer Fire Department. Ms. Shukaitis stated she appreciates his efforts and everything the department does for the township. They discussed the Penn Hills Resort property and the concerns of the fire department. The Supervisors explained the rights of all property owners, the legal process that has been ongoing, the responsibilities of the property owners and also the cleanup action that will be started soon.

Executive Session: Mr. Cramer made a motion to go into executive session at 7:19 P.M. to discuss litigation, real property, personnel and security matters. Ms. Shukaitis seconded the motion. All voted aye, motion carried 3-0. Ms. Shukaitis made a motion to return to regular session at 8:35 P.M. Mr. Cramer seconded the motion. All voted aye, motion carried 3-0. Mrs. Wilkins said that the Board discussed personnel and litigation matters in executive session and she asked if there were any motions. Ms. Shukaitis made a motion to <u>authorize Township</u> Manager to proceed with cleanup plans at the Penn Hills property and the Township Solicitor to communicate via letters with the property owners. Mr. Cramer seconded. All voted aye, motion carried 3-0. Mr. Cramer made a motion to <u>approve Road Department raises starting 5/17/2021 of \$1.50/hour retroactive to</u> 1/1/2021, except for Bradley Dailey's rate will be \$16.50/hour including \$1.50/hour raise, and starting 7/5/2021 work hours will be 7:00 A.M. – 3:30 P.M. Ms. Shukaitis seconded the motion. All voted aye, motion carried 3-0. Ms. Shukaitis made a motion to <u>authorize Township Solicitor to draft Zoning Ordinance regarding</u> the request from Suburban Realty zone change once the township receives the lot consolidation plan. Mr. Cramer seconded. All voted aye, motion carried 3-0.

There being no further business, Mr. Cramer made a motion to <u>adjourn the meeting at 8:38 P.M</u>. Ms. Shukaitis seconded the motion. All voted aye, motion carried 3-0.
