MEETING MINUTES

REGULAR MEETING, June 15, 2021, 7:30 P.M.

The Regular Meeting of the Stroud Township Board of Supervisors was called to order by Chairwoman & Secretary, Christine A. Wilkins at 7:30 P.M. and was conducted for a live and virtual on-line meeting of the Board. Also attending were Vice Chairwoman & Ass't Secretary, Jennifer Shukaitis; Supervisor/Ass't Treasurer Edward C. Cramer; Township Manager, Daryl A. Eppley; Township Solicitor, Todd Weitzmann; Township Engineer, Donna Alker; and Recording Secretary, Janice Willey. Mrs. Wilkins began the meeting with the Pledge of Allegiance. (On June 11, a public notice was posted on Township website and Facebook page inviting remote public participation by email, phone and/or Zoom.us.)

Manager's Report: Mr. Eppley reported, regarding the Mervine Road bridge project the last document needed is a utility clearance form. Data is pending on the traffic count from Monroe County Planning Commission for Powerhouse Lane speed hump analysis. The net cost for 2021 Spring Cleanup is \$17,333.75. The police contract negotiations continue. All wood-framed buildings have been demolished at Penn Hills by our Road Crew. He will be meeting on Thursday with the new owner to discuss their planned activities on the property. Our application agreement with DEP for section 902 Municipal Recycling Program award for \$350,000 was submitted for signatures. The American Rescue Plan application was submitted to PA Department of Community and Economic Development. The Lessig Lane bridge repair project is now complete. The HSPS Plan Update committee meets on June 30 to discuss a draft plan. Park patrol reported lots of local activity at our parks.

<u>Public Works Dept. Report</u>: Mr. Eppley ready Douglas Walker's report. The Road Crew has been working on the following: The main focus was on the Penn Hills property, demolition and scrapping; We paved cart paths #1 and #13 at the golf course; We are very busy at Gaunt Road; Patched a few areas at Gaunt Road that needed attention; And as always we are working hard on the "Request for Action" forms as they come in.

<u>Police Report</u>: Officer Raymond represented the Police Department who gave a summary of the activity for the month. There was also a discussion on the Route 191 property where individuals are trespassing and setting up camp. Officer Raymond said the department did get in contact with the property owners and informed them this was happening. However, the trespassers have not been caught.

Solicitor's Report: Nothing to report outside of Executive Session.

Engineer's Report: Mrs. Alker reported she will be meeting with someone from DEP regarding MS4 next week. There will be an inspection and a review of our documents. She is continuing to work with the Planning Commission and Bill Cramer on Zoning Ordinance Amendments, and the next meeting is scheduled for June 21 at 7:00 PM. All the documents have been collected for The Brushy Mountain Road and Route 447 drainage Project and the packet is ready to go to Mario Scavello's office for grant consideration. We are trying to get the NPDES for St. Luke's Route 611 road improvements and the notice of termination completed. The Conservation District did send some comments that need to be changed on the plans. There is a NOT form that needs to be signed by the Township. She is continuing to attend the Technical Committee meetings regarding Act 167.

Fire Department Report: There was no one from the Fire Department at the meeting.

Ms. Shukaitis seconded the motion. All voted aye, motion carried 3-0.
