The Regular Meeting of the Stroud Township Board of Supervisors was called to order by Chairwoman & Secretary, Christine A. Wilkins at 9:05 P.M., at the Stroud Township Municipal Center, 1211 North Fifth Street, Stroudsburg, Pa.. Also present were Vice Chairwoman & Ass't Secretary, Jennifer Shukaitis; Supervisor/Ass't Treasurer Edward C. Cramer; Township Manager, Daryl A. Eppley; Township Solicitor, Todd Weitzmann; and Recording Secretary, Janice Willey.

Park Patrol saw a significant increase in local residents in our parks this summer. Our Fall leaf collection schedule postcards have been mailed.

<u>Public Works Dept. Report:</u> The Road Department finished paving the entrances to Hickory Valley Park, Pine Brook Park North and South, and Brodhead Creek Park. Paving in front of the golf course maintenance building is complete. Breezy View prepped for paving and they are continuing to trim canopies over roadways. As always they are working hard on the "Request for Action" forms as they come in.

<u>Police Report</u>: Officer Raymond gave his insight on Short-Term Rentals from a police officer point of view. He also reported thirty eight traffic contacts this past month, which is very low and this is due to Covid restrictions and trying to keep everyone safe. There was one assault and no robberies.
