## TOWNSHIP OF STROUD BOARD OF SUPERVISORS MEETING MINUTES

## September 17, 2024, at 7:00 P.M.

The Regular Meeting of the Stroud Township Board of Supervisors was called to order by Chairwoman & Secretary, Jennifer Shukaitis at 7:00 P.M., Also present were Vice Chairman & Ass't. Treasurer, Edward Cramer; Township Manager, Daryl A. Eppley; Township Engineer, Todd Holmes, of Reilly Associates; Township Solicitor, Todd Weitzmann; and Recording Secretary, Janice Willey. Supervisor/Ass't. Secretary, Susan Lyons attended the meeting via Zoom. Ms. Shukaitis began the meeting with the pledge of allegiance.

<u>Public Comments</u>: (Non-Agenda Items) Deborah Olson read from a letter about ongoing issues on 337 Poplar Valley Road West. Residents from Penn Estates and Property management from Penn Estates attended the meeting to discuss their concerns with Short Term Rentals. They wanted the board to know the issues they are still having and the board advised them that most of these issues can be resolved with their own board within Penn Estates.

<u>Treasurer's Report</u>: Month of August, 2024. Mr. Cramer made a motion to <u>accept the Treasurer's Report for the Month of August, 2024. Ms. Lyons seconded the motion. All voted aye, motion carried 3-0.</u>

Manager's Report: Mr. Eppley reported the Mervine Road bridge and DEP Recycling grant reimbursement requests are in progress and should be received by November. Undated the board on the Green Light-Go project, Lessig Lane and Croasdale Lane projects, and the final phase of Penn Hills cleanup. The collection of non-resident park fees ended Labor Day weekend. The total amount of Fees collected was \$27,761.00 which will offset costs for summer weekend park patrol, security and caretaker. The four-lane Route 209 signals at Shafers Schoolhouse Road are being taken down by PennDOT's contractor. Construction continues on PennDOT's Glenbrook Road bridge. The in-stream restriction goes into effect October 1 unless an extension is granted by the state. The budget/finance committee of Police Commission meets again October 4 when more data is expected to continue work on the 2025 Police budget. The fall leaf collection schedule is posted on township website and Facebook and the postcard is scheduled to be mailed in a few days.

<u>Public Works Dept. Report</u>: Mr. Eppley read from Josh Cramer's report, which included their continuing work on MS4 projects, cutting back on road shoulders, repairs due to washouts from recent storms, road

maintenance, completion of paving project at the Arlington Fire House. And busy with Request for Action forms.

<u>Police Report</u>: Lieutenant Sampere attended the meeting and was able to contribute to the Penn Estates conversation.

**Solicitor's Report:** Mr. Weitzmann did not have anything to report outside of Executive Session.

**Engineer's Report**: Todd Holmes summarized the Engineer report and gave updates on ongoing projects.

<u>Fire Department Report</u>: Brian McCartney summarized the Fire Department report and advised the board on upcoming projects and events.
