MEETING MINUTES

REGULAR MEETING, January 22, 2019, 7:00 P.M.

The regular meeting of the Stroud Township Board of Supervisors was called to order by Chairman/Secretary-Treasurer, Daryl A. Eppley at 7:30 P.M., at the Stroud Township Municipal Center, 1211 North Fifth Street, Stroudsburg, Pa. Also present were; Vice-Chairman & Ass't Secretary, Christine A. Wilkins; Supervisor/Ass't Treasurer, Edward C. Cramer; Township Solicitor, Todd Weitzmann; Recording Secretary, Janice Willey.

Public Comments: Chairman asked if there were any public comments. Pat Henley thanked the Road Department for their work over the weekend. Luna Mishoe agreed saying they did a great job. Bill Unruh asked if the meeting agendas could be posted on our website or social media (Township Facebook page) prior to the meetings. Mr. Eppley said he would look into it but the final agendas are usually complete between 4-5 PM. If anyone from the public requests one we do and have in the past emailed copies to them. Mr. Cramer asked what was the reason for this request. Bill Unruh said people have asked him if he knew what was on the agenda and thought it would be helpful. Engineer's Report: Mr. Eppley reported, Donna Alker is looking for us to work with her on a draft Pollution Reduction Plan that ties into the MS4 Project. She attended a conference recently with the Conservation District and she would like to meet with us to finalize this Pollution Reduction Plan before there is a public comment period for 30 days.
