#### **MEETING MINUTES**

### SPECIAL MEETING, February 28, 2019, 1:00 P.M.

A Special Meeting of the Stroud Township Board of Supervisors was called to order by Vice-Chairman & Ass't Secretary, Christine A. Wilkins at 1:13 P.M., at the Stroud Township Municipal Center, 1211 North Fifth Street, Stroudsburg, Pa. Also present were Supervisor/Ass't Treasurer, Edward C. Cramer; Township Solicitor, Todd Weitzmann; Recording Secretary, Janice Willey. Chairman/Secretary-Treasurer Daryl Eppley recused himself earlier during the Public Hearing at 1:00 PM.

Public Comments: Mrs. Wilkins asked if there were any public comments, there were no public comments.

#### **New Business:**

1. Adopt Resolution No. 2019-35 Authorizing an Application to the Pennsylvania Municipal Assistance Program. Mr. Eppley, seated with the public, explained the Townships of Stroud, Hamilton, Pocono and Stroudsburg Borough are updating their Multi-Municipal Comprehensive Plan. Eppley as Township Manager Pursuant to the Commonwealth of Pennsylvania Second Class Township Code. Mr. Cramer moved to adopt Resolution No. 2019-36 Authorizing the Appointment and Hiring of Daryl A. Eppley as Township Manager and Further Authorizing the Board of Supervisors to Approve, Enter into, and Execute an Employment Agreement with Daryl A. Eppley as Township Manager Pursuant to the Commonwealth of Pennsylvania Second Class Township Code. Mrs. Wilkins seconded the motion. Mr. Cramer and Mrs. Wilkins voted aye, motion carried 2-0.

   A. Eppley as Township Secretary/ Treasurer. Mrs. Wilkins seconded the motion. Mr. Cramer and Mrs. Wilkins voted aye, motion carried 2-0.
