

**TOWNSHIP OF STROUD**

**MEETING MINUTES**

**SPECIAL MEETING, March 31, 2020, 3:00 P.M.**

The Special Meeting of the Stroud Township Board of Supervisors was called to order by Chairwoman & Ass't Secretary, Christine A. Wilkins at 3:00 P.M., at the Stroud Township Municipal Center, 1211 North Fifth Street, Stroudsburg, Pa. Also present were Supervisor/Ass't Treasurer, Edward C. Cramer; Vice Chairwoman, Jennifer Shukaitis; Township Manager, Daryl A. Eppley; Township Solicitor, Todd Weitzmann; Public Works Superintendent, Douglas Walker; and Recording Secretary, Janice Willey.

**Public Comments:** (Non-Agenda Items) No public comments.

**New Business:**

1. **Open Quarry Stone and Road Construction Materials Bids.** Mr. Weitzmann opened and read the bids aloud (see attached spreadsheet for results) Mr. Cramer made a motion to **table the bids for further review and will award at the next Board of Supervisors' Meeting on 4/7/2020.** Ms. Shukaitis seconded. All voted aye, motion carried 3-0.
2. **Discuss Knights of Columbus Fishing Contest Scheduled for April 18 at Brodhead Creek Park.** Ms. Shukaitis made a motion to **recommend postponing the scheduled date of the Knights of Columbus Fishing Contest on April 18 at Brodhead Creek Park.** Mr. Cramer seconded. All voted aye, motion carried 3-0.
3. **Other Business:** Ms. Shukaitis made a motion to **move Leaf Collection and Spring Clean Up. Leaf Collection will be May 4<sup>th</sup> through May 15<sup>th</sup> and Spring Clean Up May 27<sup>th</sup> through May 30<sup>th</sup>.** Mr. Cramer seconded. All voted aye, motion carried 3-0. Ms. Shukaitis made a motion to **re-open Gaunt Road on May 4<sup>th</sup>.** Mr. Cramer seconded. All voted aye, motion carried 3-0. Ms. Shukaitis made a motion to **adjust the Fee Schedule Drop Off costs. The following has changed: Pick-up Truck from \$10.00 to \$15.00, One Ton Dump Truck from \$15.00 to \$25.00, Single Axle Utility Trailer from \$10.00 to \$20.00, Tandem Axle Utility Trailer from \$15.00 to \$25.00, Fifth Wheel Dump Trailer from \$75.00 to \$100.00, Chipper/Forestry Truck – Wood Chips from \$10.00 to \$25.00. And under Rules and Regulations #5 to replace the 1.5% interest charge to a flat fee of \$35.00, and #1, change the acceptable size from 30" maximum length and 18" maximum diameter.** Mr. Cramer seconded. All voted aye, motion carried 3-0.

There being no further business, Mr. Cramer **made a motion to adjourn the meeting at 4:54 P.M.** Ms. Shukaitis seconded the motion. All voted aye, motion carried 3-0.
